Career Development and Transferable Skills Training	£300	For 2011/12, the AHRC will be providing a sum of £300 per doctoral studentship towards Career Development and Transferable Skills Training. Although this fund is linked to individual student numbers, it is not intended to be spent on the training needs of individual students, i.e. the funding should not be allocated to an individual. The fund is intended to support generic training primarily for the benefit of Research Council funded researchers, though the funds should be used in a way that will have as broad an impact as possible on other researchers. This is in addition to the £200 uplift in fees, in common with the other Research Councils. This applies only to new starters in 2011/12 and will only be awarded in 2011/12.
Research Training Support Grant	£200	£200 per doctoral student is allocated to the Research Training Support Grant. Additional Funding on BGP awards	£550	Due to adjustments made to full BGP awards following the Spending Review, for 2011/12 only, an additional £550 per doctoral studentship has been allocated to these awards, which may be used for either individual or generic skills training, overseas travel or placements. This applies to new starters only and does not affect BGP-CB or other studentship awards.
CDA Maintenance payment	£550	£550 per annum is added to the student stipend for CDA students and is intended to help towards any additional costs incurred by CDA studentships due to the need to work both at the host RO and the non-academic partner sites.

\* A student is only entitled to the total maintenance award if the course or programme of study, and registration on the course, is for the full academic year (i.e. 1 October 2011 - 30 September 2012). If the course or programme of study starts later than 1 October or finishes earlier than 30 September, then the payment should be pro-rated to reflect the actual duration.

\*\* The figures shown for fees and maintenance are the annual entitlement figure, due if registration is for the full year. The fees and maintenance will be paid to the RO in equal quarterly installments.

\*\*\* Part-time rates are indicative and are based on a doctoral registered student studying for 60% of full-time study (i.e. 5 years of study). Students may study for less (but no less than 50% of full-time study) or more than 60% of full-time study and agree with their RO a percentage of the full-time rate accordingly.
